The TidePointe Community Charitable Fund was established within the Community Foundation of the Lowcountry by residents of TidePointe to reflect the generosity and caring spirit that is present within the TidePointe community.

Purpose:

The purpose of the TidePointe Scholarship Program is to assist qualified employees and dependents of employees who have shown significant academic and/or personal achievement and who plan to pursue post-secondary education at an accredited technical school, college or university.

The eligibility rules for this scholarship are as follows:

An employee applying for an educational scholarship must:

- Have received a high school diploma or equivalent;
- Be a citizen or legal resident of the United States of America;
- Work an average of 12 hours a week at TidePointe;
- Have completed at least one year of employment at TidePointe;
- Have and maintain a good work and attendance record;
- Demonstrate or show evidence of financial need; and
- Not be eligible for, or be a participant in, any Classic Residence by Hyatt Tuition Assistance Program.

An employee dependent applying for an educational scholarship must:

- Be the legal dependent of a TidePointe employee who works an average of 32 hours per week;
- Be the legal dependent of an employee who has completed at least one year of employment at TidePointe;
- Be a high school senior scheduled to graduate in 2010 OR have a high school diploma or equivalent;
- Be 17-24 years of age;
- Be unmarried;
- Demonstrate or show evidence of financial need; and
- Be a citizen or legal resident of the United States of America.
