## **The R and J Matchett Scholarship Scholarship Guidelines & Instructions for the 2010-2011 Academic Year**

### **PURPOSE**

**The R and J Matchett Scholarship Fund** was established in 2007 to assist qualified students in pursuit of a post-secondary education who plan to successfully complete a course of study in a current or emerging occupational, technical, or skilled labor field at a technical college, trade school, or community college.

### **ELIGIBILITY/CRITERIA**

- A. Applicant must be a high school senior scheduled to graduate in the spring of the current school year from a high school located in Beaufort, Jasper, or Hampton counties.
- B. Applicant must be a U.S. citizen and legal resident of Beaufort, Jasper, or Hampton counties in South Carolina.
- C. Applicant must be accepted to a technical college, trade school, or community college located within a 150 mile radius of Hilton Head Island, *with preference given to applicants attending a technical college, trade school, or community college located in Beaufort, Jasper, or Hampton counties.*

Applicants with the desire to attend a specialized educational training program outside of the geographic requirements stated above may be considered at the discretion of the Scholarship Advisory Committee.

- D. Applicants must be pursuing a post-secondary education in a current or emerging occupational, technical, or skilled labor field; *excluding all religious and/or culinary arts training programs.*
- E. Applicant must demonstrate financial need based on the applicant's and applicant's parent(s) or guardian(s) federal tax returns for the **last two years**, and a completed FAFSA form (Free Application for Federal Student Aid)
- F. Applicant must demonstrate current and past academic achievements, along with the sincere willingness to work hard to accomplish future educational and personal goals.

### **APPLICATION PROCEDURE**

**Submit all application materials by Friday, April 23, 2010.** Application materials should include:

- A. A completed **The R and J Matchett Scholarship Application Form** (available online at [www.cf-lowcountry.org](http://www.cf-lowcountry.org) or at the Community Foundation of the Lowcountry office, high school guidance office).
- B. A *certified* copy of the applicant's most recent transcript(s) showing grades for at least the last two years.
- C. A typed essay (approximately 500 - 800 words) describing why you have chosen to pursue the educational and career field you have selected, how your experiences and achievements have led you to this decision and how this scholarship will assist you in achieving your educational, personal and future career goals. Include examples of how you have demonstrated a willingness to work hard to accomplish your current and past achievements.
- D. **Three Recommendation Forms** to be completed by an employer, family member, current teacher, or school personnel explaining the applicant's ability to successfully complete a course of study at an technical college, trade school, or community college.
- E. Each applicant must attend a personal interview with The R and J Matchett Scholarship Advisory Committee if chosen as a finalist.

### **SELECTION OF RECIPIENTS**

- A. The Scholarship Advisory Committee shall select scholarship recipients (subject to approval by Community Foundation of the Lowcountry Board of Trustees).
- B. Scholarship funds will be awarded to cover educational costs, including but not limited to, tuition/fees, room and board, and books. Specific costs to be covered will be at the discretion of the Scholarship Advisory Committee.
- C. Scholarships are awarded without regard to race, sex, religion, age or national origin.

### **ANNOUNCEMENT OF SCHOLARSHIP AWARDS**

- A. The Community Foundation of the Lowcountry will send an official award letter and related information to each recipient.
- B. A public announcement of scholarship recipients will be arranged by the Community Foundation of the Lowcountry.
- C. Recipients may be further recognized through Awards Day programs at their schools.

### **DISTRIBUTION OF SCHOLARSHIP FUNDS**

- A. The Scholarship Advisory Committee or Community Foundation staff members will advise all scholarship recipients regarding how the scholarships will be paid and review the students' responsibilities to The R and J Matchett Scholarship Fund. These responsibilities include sending transcripts at end of the year, and providing notification of all address changes or changes in student status or enrollment.
- B. In accordance with the Community Foundation's policy, scholarship funds will be paid in the form of a check made payable to the college/school of the scholarship recipient. Checks will be mailed to the college/school on a pre-established date (e.g. August 1). Notification of payments will be sent to scholarship recipients.

4.) Current and last year's Federal Tax Returns for you and your parents.
5.) Recommendation Forms from 3 sources.
